CONDITIONS OF CERTIFICATION

1. When used in conjunction with A-60 Class steel or A-60 Class aluminium bulkheads and decks with approved insulation arrangements, refer to MCT Brattberg installation drawings.
2. For applications in A-0, A-15, A-30 Class steel bulkheads and decks, a 200mm diameter ring of A-60 insulation is to be provided around one side of the bulkhead penetration or underside of deck penetrations. The insulation on penetration itself shall be as per the A-60 tested specimens.
3. RGP cable penetrations consisting of: MCT Brattberg mild, stainless Steel or Aluminium Frames filled with MCT Brattberg 60mm thick Lycron self lubricating transit blocks of type standard, add block, U block and Handi block.
4. RGP penetration with reinforced insert block BOF is available as EMC conversion.
5. RGP cable penetration is welded to the deck or bulkhead, two variants of frames available for welding S and SFR. S and SFR frame are fully welded to both sides of the division.
6. RGP transits may be bolted to the deck or bulkhead with two variants of frame: SFRB and SFRBO.

8. All cables used shall be fire-retardant and approved for use in marine applications, with diameter up to 110mm and blown optical fiber with diameter up to 18mm.
9. Cable transits are to be fitted with the as-tested insulation materials in all cases. Any modifications are subject to acceptance by the final project authority and the attending surveyor.
10. Composition, application and installation of subcomponents, including adhesives, seals and any fire retardants, to be maintained in production and used in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
11. Production items of the subject equipment are to be manufactured in accordance with either an approved Production Quality Assurance System (Module D), a Product-Quality Assurance System (Module E) or a Product Verification Process (Module F), as applicable. The UK Conformity Mark cannot be affixed to the product until a conformity assessment module is in place.
12. Each item, batch or lot of the subject equipment is to be issued with a "UK Declaration of Conformity" and have the "UK Conformity Mark" affixed after a conformity assessment module is in place.
